I recognize that by attending and/or participating in the Quorum “Un”Leashed event is an activity that presents some risk of injury and/or illness. I agree that my/my child’s/my family’s/my dog’s safety is primarily my responsibility, and not that of Quorum staff and volunteers, any invited Dog Show judges and sponsors, any observers and participants attending the event.

I also recognize that the Quorum staff and volunteers, any invited Dog Show judges and sponsors, and any observers or participants assumes no liability whatsoever for personal injuries, injuries to my animal, or property damage that may arise from my attendance and/or participation in this event.

5. Quorum, any invited Dog Show judges and sponsors, and any observers or participants reserve the right to ask any person (s) and their dog(s) to leave the event at any time for any reason.
